
### **MEET CVA's POLICY & LEGISLATIVE INTERN**

### Targeted Priorities for the 2025 Legislative Session



Second Generation Anticoagulant Rodenticides (SGARS) are harmful poisons designed to reduce rodent populations. These poisons, which are eaten by small rodents, are then ingested by other animals higher up in the food chain such as birds of prey, foxes, and even cats and dogs. SGARs are anticoagulants, meaning any animal that ingests this poison bleeds out from the inside,

resulting in a slow and painful

death.

**Black Bear Hunting** 

Black Bear Hunting is seen as the solution to the growing number of bear sightings in the state. However, as stated by the State Department of Energy and Environmental Protection (DEEP), "the primary contributing factor to bear problems is the presence of easily accessible food sources near homes and businesses." It is

pollen, fruit, and even dew on the leaves of treated plants containing the poison which is toxic to bees and other insects. We are currently in the midst of a bee and insect population crisis, and we have also seen a loss of roughly 3 billion birds in the last 50 years. Studies have shown that 95% of pregnant women in the US have neonics in their bodies and 50% of the population does as well, with children representing the highest concentration.




# **Broko's Bill**
