



It's a Wrap - With Some Wins for CT Animals in Hartford!



With the 2024 session of the Connecticut General Assembly concluded, we give a grateful shout-out to all our supporters who took the time to contact state lawmakers to let them know your perspective on protecting CT wildlife, pets, and other animals. Your efforts paid off and, together, despite a short session, we had some successes this year.

CT has finally joined 42 other states to ban the cruel practice of dog racing by closing a loophole in the statutes that would have allowed a new track to open. As Governor Lamont said when he signed the law: "It's mindboggling to think that at one time people considered this a legitimate sport, and I give credit to animal advocacy groups for their activism that has raised

Lights Out for Spring Migration Season!

It's peak bird migration time in CT and throughout the northeast, according to the Cornell University Laboratory of Ornithology's BirdCast analysis which maps out the periods of highest nightly aerial bird density across the U.S. It's a perilous time for the hundreds of millions of birds making their long, arduous journeys north, especially at night when they can become disoriented by city lights and collide with windows.

You can do your part to make the flight safer by turning off nonessential lighting from 11:00 p.m. to

6:00 a.m., or drawing curtains to keep light inside. All types of buildings pose a risk though studies show most collisions in the U.S. occur at residences and low-rise buildings.

You can also prevent bird collisions during the day by **making glass more visible**. Birds don't see glass as a solid surface and can fly into it at full speed, often resulting in injury or death. Simple window treatments may include decals or cords spaced two inches apart on the outside of glass.
